Overview

Rep. Brian Fitzpatrick is a vocal supporter of meaningful and enduring legislation on climate. He advocates for foundational governmental reform, including limiting gerrymandering and enacting term limits. Prior to being elected to Congress, he served as a Special Assistant United States Attorney and an FBI Special Agent and Federal prosecutor. He also served as the National Director of the FBI's Campaign Finance and Election Crimes Enforcement Program, and as a National Supervisor for the FBI's Public Corruption Unit, and he was embedded with the U.S. Special Forces as part of Operational Iraqi Freedom.

Positions on Energy and Climate

Rep. Fitzpatrick supports climate and the environment as an integral part of his legislative agenda. He authored the bi-partisan Market Choice Act which puts a specific price on carbon dioxide and other greenhouse gas emissions and provides for a border adjustment that protects American jobs from economies with less stringent carbon emissions limits.

Rep Fitzpatrick is a public supporter of climate legislation, and is a member of the Climate Solutions Caucus. He has worked together with multiple members in a bipartisan effort to encourage both Republicans and Democrats to move forward on climate.

Rep. Fitzpatrick is a bipartisan advocate for climate action. He is ranked as the most bipartisan member of the House by The Lugar Center by a wide margin and has consistently supported and introduced legislation focused on climate.
